What is Identity Theft?

Identity theft is the misappropriation of another person's identifying information in order to:

- obtain credit fraudulently from banks and retailers;
- steal money from the victim's existing accounts;
- apply for loans;
- establish accounts with utility companies;
- rent an apartment;
- file for bankruptcy;
- obtain a job; or
- achieve other financial gain using the victim's name.

What is the Impact of Identity Theft?

The average identity theft crime victim spends up to 200 hours to repair the damage caused by an identity theft crime.

Eligibility

- Anyone who has not lost any personal effects and/or documents containing important personal particulars during the last 3 months. e.g. Identity Card, Passport etc.
- Age between 21 - 70 years old.
- Singapore Citizen or Permanent Resident.

Summary of Coverage (Worldwide)

1. Monetary Loss

Financial losses suffered by you as a direct result of an identity fraud or fraudulent use of ATM/Credit Card and shall include the loss of monies owing to the transfer of funds and the incurrence of debt.

2. Expenses

Lost Wages

This may be time lost from work for which the Insured received no compensation.

Attorney's Fee

The Insured is sued because crimes were committed in the Insured's name. Sometimes assistance in finding the Insured an attorney is offered should the victim need one.

Others Expenses

These might include the services of a notary; express overnight mail charges for sending needed documentation; long-distance phone calls to merchants, law enforcement, financial institutions and credit agencies to report or discuss an incident; and transportation costs to pick-up and deliver items needed to verify the Insured's identity.
