## TERMS AND CONDITIONS FOR ALLIANZ PRODUCT PROMOTION (“PROMOTION TERMS”)

3. By participating in this Promotion, you hereby agree to be bound by these Promotion Terms.
4. The Allianz insurance products which are eligible for this Promotion are:
  - a. Allianz Accident Protect Plus,
  - b. Allianz Home Protect,
  - c. Allianz Cancer Protect,
  - d. Allianz Hospital Income Protect, and
  - e. Allianz SMART SME,(the “Eligible Products”).

### Promotion

5. You will enjoy a Discount on premiums payable on an Eligible Product if you purchase the product during the Promotion Period and using the relevant Promo Code through:
  - a. the Allianz website ([www.allianz.sg](http://www.allianz.sg));
  - b. an Allianz telemarketing representative; or
  - c. an Allianz intermediary via AZConnect.
6. The table below sets out the Discount applicable to each Eligible Product and the relevant Promo Code to be applied at the point of application:

7. To be eligible for the Discount:
  - a. the application and full premium payment for the Eligible Product must be received and accepted by Allianz During the Promotion Period, and
  - b. the Eligible Product policy must be issued within the Promotion Period.
8. Only the main policyholder will be entitled to the Discount.
