TERMS AND CONDITIONS FOR ALLIANZ HOME PROTECT PLAN PROMOTION (“PROMOTION TERMS”)

1. This Allianz Home Protect Plan Promotion (“**Promotion**”) is organised by Allianz Insurance Singapore Pte. Ltd. (“**Allianz**”).
2. This Promotion is valid from 16 July 2026 to 30 September 2026, both dates inclusive (“**Promotion Period**”).
3. By participating in this Promotion, you hereby agreed to be bound by these Promotion Terms.

Promotion

4. If you purchase an Allianz Home Protect policy (the “**Policy**”) from Allianz during the Promotion Period through AZConnect or Allianz.sg and the total first year premium for the Policy must be a minimum of **S\$200 inclusive of GST**:
 - 4.1 You will be entitled to a 30% discount off your total first year premiums for all plan types (“**Promotional Discount**”), by applying the Promo Code “**AZHPSG61**”:
 - 4.2 Your application for the Policy (“**Application**”) and insurance premium payment for the Policy must be received and accepted by Allianz and the Policy successfully issued during the Promotion Period, to be entitled to this Promotional Discount.
