## TERMS AND CONDITIONS FOR ALLIANZ ELECTRIC MOTOR PROTECT PLAN PROMOTION (“PROMOTION TERMS”)

1. This Allianz Electric Motor Protect Plan Promotion (“**Promotion**”) is jointly organised by Allianz Insurance Singapore Pte. Ltd. (“**Allianz**”) and Standard Chartered Bank (Singapore) Limited (“**SCBSL**”).
2. This Promotion is valid from 1 April 2026 to 30 June 2026, both dates inclusive (“**Promotion Period**”). Allianz Electric Motor Protect is underwritten by Allianz and distributed by SCBSL.
3. By participating in this Promotion, you hereby agree to be bound by these Promotion Terms.

### Discount

4. If you purchase an Allianz Electric Motor Protect policy (the “**Policy**”) from Allianz during the Promotion Period through SCBSL, you will be entitled to a 10% discount off your total first year premiums for all plan types. (“**Promotional Discount**”).
5. Only the main policyholder will be entitled to the Promotional Discount. Your application for the Policy (“**Application**”) and insurance premium payment for the Policy must be received and accepted by Allianz during the Promotion Period to be entitled to this Promotion.
6. You must be a first-time applicant of the Policy and not hold any valid private motor car insurance policies, Comprehensive, Third-Party Fire and Theft Only, or Third-Party Only insurance policies underwritten by Allianz as of the date of the Application.
7. The Promotional Discount is non-transferable, non-assignable, and not exchangeable for cash, credit or any other item, whether in part or in whole.

### Voucher

10. Applicants who have successfully purchase Allianz Electric Motor Protect from 1 April 2026 to 30 June 2026 (inclusive of both dates) (“**Voucher Promotion Period**”) shall receive a \$80 Voucher (the “**Voucher**”).
11. To qualify for this Promotion:
  - i. New sign-ups must be submitted during the Voucher Promotion Period;
  - ii. Only the Comprehensive Plan is applicable for the Voucher and the purchased policy must not be cancelled during the Voucher Promotion Period;
  - iii. Premium payment must be successfully received by Allianz during the Voucher Promotion Period; and
  - iv. Policyholder must provide marketing consent to Allianz to be contacted via their email address to receive the Voucher from Allianz.

### Voucher Redemption

If you are eligible to receive the Voucher, all updates regarding Voucher redemption will be communicated to the main policyholder by Allianz via the email address provided during the application. An email on the Voucher redemption will be issued to the main policyholder within 90 days after campaign closure at their email addresses or mobile number registered with Allianz at the time they apply for the policies subject to the receipt of the applicants' marketing consent ("**Redemption Email**"). Allianz may at its sole and absolute discretion at any time and without prior notice substitute or replace the Voucher with any other Voucher of equal or similar value.
14. By purchasing the Policy during the Promotion Period for the qualification of the Voucher, you consent to the collection, use, and disclosure of your Personal Data by Allianz to a third party merchant for the purpose of Voucher redemption only.
15. The Voucher and Redemption Email are not transferable or exchangeable for cash, credit or any other item in part or in whole. A Redemption Email that has expired or is lost will not be replaced.
16. The Voucher must be redeemed in accordance with the instructions stated in the Redemption Email. Any Voucher not redeemed by the expiry date indicated on the Redemption Email at the redemption location stated, or otherwise stipulated by the Allianz, SCBSL, and/or relevant third party merchant(s), will be forfeited.
17. The Voucher is provided by a third party merchant(s). Neither Allianz nor SCBSL is the supplier of the Voucher. Neither is obliged to assist or act on your behalf in communicating with the supplier of the Voucher for any reason. You shall accept the Voucher as it is and subject to any terms and conditions that the merchant(s) supplying the Voucher may impose.
18. No payment or compensation whether in cash, credit or kind shall be made for expired, unused, lost, misplaced, defaced, stolen or damaged Voucher.
19. Allianz and SCBSL make no representation or warranty whatsoever as to the quality merchantability or fitness for purpose or any other implied terms or conditions with respect to the Voucher. Allianz and SCBSL accepts no responsibility or liability for the acts or goods or services of the merchant(s) supplying the Voucher, or for any delay, postponement, non-delivery, non-performance or defects in the Voucher. Neither Allianz nor SCBSL will be liable for any injury, loss (whether foreseeable or not), claim or damage whatsoever suffered or incurred (whether in common law or equity) arising from or in connection with, directly or indirectly, the Voucher, to the fullest extent permitted by law. Any dispute about the quality or condition of the Voucher is to be resolved directly with the merchant(s) supplying the Voucher. Allianz and SCBSL are not agents of any merchant(s) supplying the Voucher or vice versa.
20. If you cancel your Policy at any time before the Policy expiry date for whatever reason, Allianz reserves the right to deduct the value of the Voucher or the applicable discounts from the refund premium (if applicable) in accordance to the policy terms and conditions.

### General Terms

21. The Policy is underwritten by Allianz and distributed by SCBSL. SCBSL shall not be liable in any manner whatsoever regarding your application or the contract of insurance. Guaranteed elements (if any) are obligations of Allianz only. All insurance products are not deposits with, obligations of, or guaranteed by SCBSL.
22. Your purchase of the Policy is subject to the terms and conditions of, and acceptance by, Allianz. Please refer to the full terms and conditions, and exclusions listed in the policy contract. SCBSL does not accept any responsibility regarding any statement made in, omission or inclusion of any provisions of, the relevant policy

terms and conditions, nor shall SCBSL be held liable in any manner whatsoever in respect of your application for the relevant policy and/or the relevant policy terms and conditions.

23. Each of Allianz and SCBSL may at any time, without any prior notice or liability to you, vary the terms and conditions of this Promotion or withdraw or discontinue the Promotion at any time. The decision of Allianz and SCBSL on all matters relating to this Promotion, including determining your eligibility to participate, shall be at their absolute discretion and will be final and binding.
24. Allianz reserves the right to change the Terms and Conditions of these Promotion Terms at its sole discretion without any prior notice.
25. Allianz decision on all matters relation to these Promotion Terms shall be final, conclusive and binding. No appeals shall be entertained.
26. In the event of any inconsistency between these Promotion Terms and any brochures, marketing or promotional materials relating to the Promotion, these Promotion Terms shall prevail.
27. A person who is not a party to these Promotion Terms has no right under the Contracts (Right of Third Parties) (Cap.53B) to enforce any of these Promotion Terms.
28. These Promotion Terms are governed by and construed in accordance with the laws of the Republic of Singapore and you agree to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
